Claus Kreß is a Professor of International Law and Criminal Law. He holds the Chair for German and International Criminal Law and is the Director of the Institute of International Peace and Security Law at the Universität zu Köln. He served as a member of Germany's delegation to the ICC negotiations from 1998 to 2017 and has served the ICC Prosecutor as Special Adviser for the crime of aggression since 2021.
